



LIMITED WARRANTY



Model: CPLT, CPKT

This heating or air conditioning product is warranted by Goodman Manufacturing Company, L.P. ("Goodman") to be free from defects in materials and workmanship under normal use and maintenance, as described below:

- The COMPRESSOR is warranted for the LIFETIME of the original purchaser and his or her spouse, or for so long as either of them owns the home in which it was originally installed (whichever ends first), except as provided below. However, this lifetime warranty applies only if (1) the unit is installed in an owner-occupied, single-family residence, and (2) the unit is installed with a new indoor coil or air handler to which it is properly matched by the installer, and (3) the unit is registered with Goodman within 60 days after either the original installation or the closing on your home (if the product is installed in a new home). Registration can be completed online at www.goodmanmfg.com or by filling out the card accompanying this warranty.
- All remaining parts (and the compressor, if the lifetime warranty does not apply) are warranted for a period of 10 YEARS, except as provided below.

Neither warranty continues after the product is removed from the location where it was originally installed.

Neither warranty applies to, and no warranty is offered by Goodman on, any product ordered over the Internet.

Regardless of time of registration, the warranty period begins on the date of the original installation. If that date cannot be verified, the warranty period begins three months after the month of manufacture (as indicated by the first four digits of the serial number (yymm)).

As its only responsibility, and your only remedy, Goodman will furnish a replacement part, without charge for the part only, to replace any part that is found to be defective due to workmanship or materials under normal use and maintenance. For warranty credit, the defective part must be returned to a Goodman heating and air conditioning products distributor by a state certified or licensed contractor.

- Damage or repairs required as a consequence of faulty installation or application.
- Damage as a result of floods, fires, winds, lightning, accidents, corrosive atmosphere or other conditions beyond the control of Goodman.
- 3. Use of components or accessories not compatible with this unit.
- 4. Products installed outside the United States or Canada.
- Normal maintenance as described in the installation and operating manual, such as cleaning of the coils, filter cleaning and/or replacement and lubrication.
- 6. Parts not supplied or designated by Goodman.
- Damage or repairs required as a result of any improper use, maintenance, operation or servicing.
- Failure to start due to interruption and/or inadequate electrical service.
- Any damage caused by frozen or broken water pipes in the event of equipment failure.
- Changes in the appearance of the product that do not affect its performance.

This warranty gives you specific legal rights, and you may also have other rights that may vary from state to state.
